### Workshop Meeting

#### RESOLUTION #107

##### Public Hearing - Ontario County Multi-Jurisdictional All Hazard Mitigation Plan

Supervisor Champlin opened the Public Hearing at 7:00 and asked three times if anyone wished to comment. Hearing no comments, he closed the public hearing at 7:03. Councilman Rehberg made the motion to adopt the plan, seconded by Councilman Hagen.

Resolves that the Ontario County Multi-Jurisdictional All Hazard Mitigation Plan is adopted as presented.

##### Gary Baxter, Ontario County Treasurer

Supervisor Champlin introduced Mr. Baxter and asked him to explain the foreclosure procedure to the Board. Mr. Baxter explained how the process works and the County's responsibility in selling property. The Board thanked him for coming and explaining the process.

#### 2010 Budget

The Board reviewed the 2010 Budget and asked the accountant to make several changes. The Public Hearing on the 2010 Budget was set for November 11, 2009 at 7:00 pm.

#### RESOLUTION #108

##### Ontario County Snow & Ice Contract

Supervisor Champlin advised the Board that the 2010 County Snow & Ice Contract had been received and approved by Superintendent Powers. Councilman Hagen made the motion to approve the contract, seconded by Councilman Ferguson.

#### RESOLUTION #109

##### New York State Snow & Ice Contract

Supervisor Champlin advised the Board that the 2010 New York State Snow & Ice Contract had been received and approved by Superintendent Powers. Councilman Ferguson made the motion to approve the contract and authorize Supervisor Champlin to sign the agreement, seconded by Councilman Hagen.

Resolves that the New York State Snow & Ice Contract is adopted as presented and Supervisor Champlin is authorized to sign the agreement.

##### Bids for the Water Pump Control

Superintendent Powers advised the Board that only one bid was received and Larsen Engineers is reviewing it. He will let the Board know when it is back from the engineers.

#### RESOLUTION #110

##### Water Relevy

The Clerk asked the Board for permission to relevy unpaid water bills to the 2010 Town County Tax bills. Councilman Rehberg made the motion, seconded by Councilman Hagen.

Adopted: Ayes- Champlin Ferguson, Hagen, Rehberg Nays – None

Resolves that any unpaid water bills will be relevied to the 2010 Town County Tax Bills.

### November Workshop

Supervisor Champlin asked the Board if they want to have the workshop on November 25<sup>th</sup>, all agreed to cancel it.

Supervisor Champlin also asked if the Board was opposed to having the regular meeting in November on Veteran's Day since the Budget has to be completed. All agreed that the November 11<sup>th</sup> meeting was okay.

Legion Property – Supervisor Champlin advised the Board that there haven't been any new developments.
